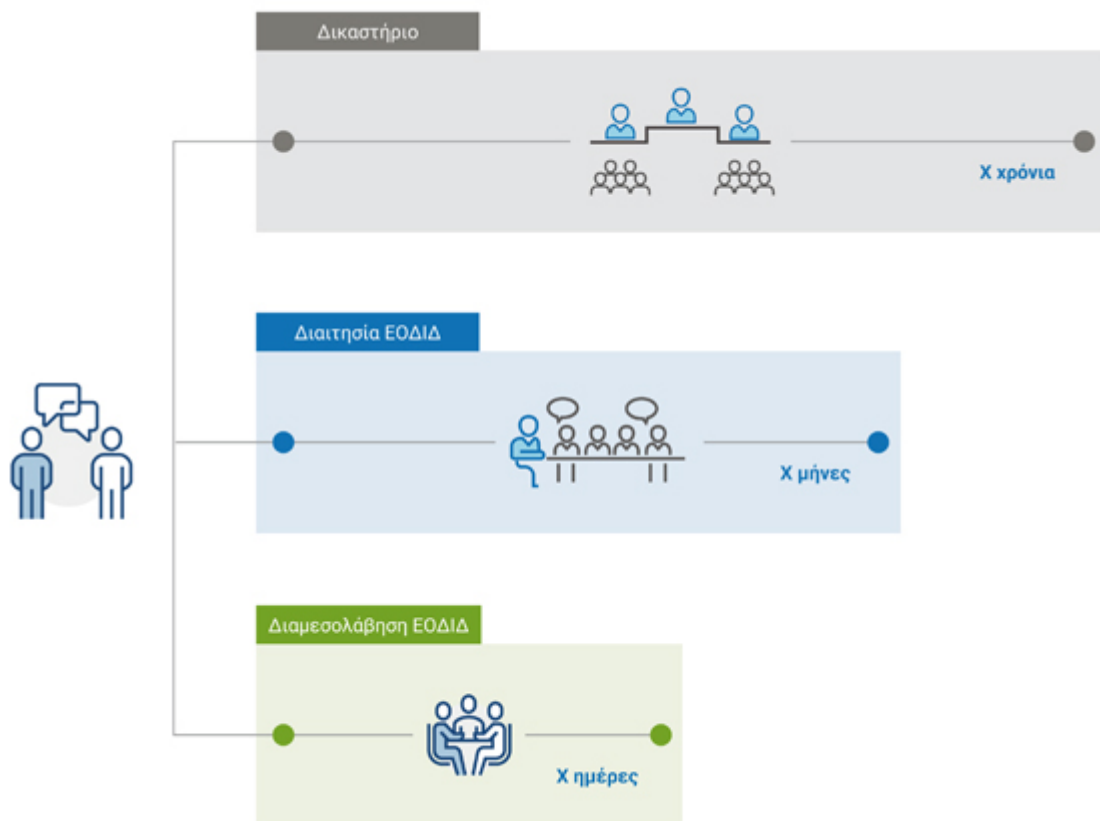

According to official data (2017 EU Justice Scoreboard, CEPEJ Study), the time needed to resolve litigated civil and commercial cases in court may reach well over 500 days in specific Member States, while resolution of administrative cases in court at times extends further than 1000 days. 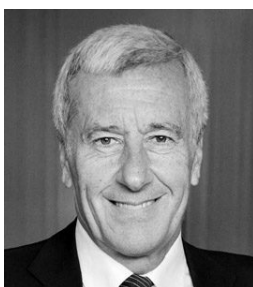
