**Austria**

Professor Mag. Dr. IRMGARD MARBOE is Professor of International Law at the Department of European, International and Comparative Law at the Law Faculty of the University of Vienna. She studied law and languages at the University of Vienna (Austria) and at the Universidad Complutense de Madrid (Spain).

Prof. Marboe is the head of the Austrian National Point of Contact (NPOC) for Space Law of the European Centre for Space Law (ECSL) since 2008. She was the chair of the working group on "National Space Legislation" of the Legal Subcommittee of the UN Committee for the Peaceful Use of Outer Space (UNCOPUOS), which prepared UN General Assembly Resolution 68/74 on "Recommendations on national legislation relevant to the peaceful exploration and use of outer space" (2013). She advised the Austrian government as an expert in the development of the Austrian Outer Space Act 2011 and the Austrian Outer Space Regulation 2015. Her publications in the area of space law include books and articles on telecommunication and space, national space legislation, European space law and policy, regulatory aspects of Earth observation and data policies, soft law in outer space, small satellites, and legal aspects of planetary defence. In 2016, she received the "Distinguished Services Award" of the International Institute of Space Law (IISL). Her book on "Legal Aspects of Planetary Defence" was granted the "Social Sciences Book Award" of the International Academy of Astronautics (IAA) in 2022.

She teaches courses on space law at the University of Vienna and at other European universities. In 2014/15 and in 2016 she was a visiting scholar at Stanford University (USA), and in 2016/2017 a visiting professor at Western Sydney University (Australia).

Other research focuses include international investment law and arbitration, where she has specialized in the area of compensation and damages. In addition, she is interested in culture and religion in international law as well as in Islam and international law, which led to her position as co-rapporteur of the ILA-Committee on "Islamic Law & International Law" from 2013 to 2018. Between 2008 and 2018, she was the director of the Vienna International Christian-Islamic Summer University.
