

## ➤ Arbitration Fees

### ▼ Charging Standards

If the parties file an arbitration claim or counterclaim, they shall pay the acceptance fee and handling fee in advance to HIAC according to the following standards:

#### [Acceptance fee]

Rank	Dispute amount (RMB)	Acceptance fee (RMB)
A	Up to 100,000 RMB (inclusive)	5.50% of the disputed amount, with a minimum of 3,000 RMB
B	From 100,000 RMB to 200,000 RMB (inclusive)	3.50% of the disputed amount + 2,000 RMB
C	From 200,000 RMB to 500,000 RMB (inclusive)	2.00% of the disputed amount + 5,000 RMB
D	From 500,000 RMB to 1,000,000 RMB (inclusive)	1.00% of the disputed amount + 10,000 RMB
E	From 1,000,000 RMB to 3,000,000 RMB (inclusive)	0.60% of the disputed amount + 14,000 RMB
F	From 3,000,000 RMB to 5,000,000 RMB (inclusive)	0.50% of the disputed amount + 17,000 RMB
G	From 5,000,000 RMB to 10,000,000 RMB (inclusive)	0.48% of the disputed amount + 18,000 RMB
H	From 10,000,000 RMB to 30,000,000 RMB (inclusive)	0.47% of the disputed amount + 19,000 RMB
I	From 30,000,000 RMB to 50,000,000 RMB (inclusive)	0.45% of the disputed amount + 25,000 RMB
J	From 50,000,000 RMB to 200,000,000 RMB (inclusive)	0.44% of the disputed amount + 30,000 RMB
K	From 200,000,000 RMB to 500,000,000 RMB (inclusive)	0.43% of the disputed amount + 50,000 RMB
L	More than 500,000,000 RMB	0.42% of the disputed amount + 100,000 RMB

Note: 1. The minimum charge standard for a file is 5000 RMB (including acceptance fee and handling fee).

2. A, B, C, D, E, F, G, H, I, J, K and L in the calculation formula of each file are the disputed amount of the corresponding grade.

#### [Handling fee]

Case handling fee = case acceptance fee 50%, with a minimum of 2,000 RMB.

### ▼ Fee Commitment

In principle, arbitration fees shall be borne by the arbitration tribunal according to the responsibility of the parties and the degree of support of the arbitration request. If the parties settle the case by themselves or through mediation by the arbitration tribunal, the parties may determine the proportion of arbitration fees through consultation.

If a party requests the loss of lawyer's fees and provides relevant evidence, the arbitration tribunal may support it as appropriate with reference to the extent of the responsibility of the party, the degree of support of the arbitration request, the lawyer's fees, the complexity of the case, the amount of dispute, the behavior of the party and other factors.

### ▼ Fees Charged by Other Arbitration Rules Shall Apply
